

COMPARATIVE TABLE - STANDARD ACCESS CONTRACT

Note: This table identifies the differences between the Model Standard Access Contract in Appendix 3 of the Code (**Model**) and the Electricity Transfer Access Contract (**ETAC**) and Connection Access Contract (**CAC**) in the Access Arrangement (collectively **Access Contracts**). Western Power has prepared "Reasons for Modifying the Model Access Contract" which are contained in Appendix 10 of its Access Arrangement (**WP reasons**). Where a difference between the Model and the Policy is explained in the Reasons, a reference to the relevant section of the Reasons has been made in the table below.
