### PROPOSED VARIATIONS TO WESTERN POWER'S ACCESS ARRANGEMENT FOR 2009/10 TO 2011/12: CONTRIBUTIONS POLICY

## Corrigenda for the Draft Decision on Proposed Variations to Western Power's Access Arrangement for 2009/10 to 2011/12: Contributions Policy

- 1) Paragraph 3 (page 1)

The reference to section "4.34(a)" has been changed to "4.43(a)"

- 2) Paragraph 54 (page 9)

The following sentence has been added. **"It also includes a definition of "headworks scheme" as "means the scheme described in clause 6 of this contributions policy".**" The following sentence has been amended to **"The Authority notes that these definitions only apply to the existing headworks scheme and do not include the proposed DLVCS."**

- 3) Paragraph 55 (page 9)

Paragraph 55 has been amended to **"To ensure compliance with section 2.12 of the Access Code, Western Power must amend definitions of "headworks" and "headworks scheme" in the Contributions Policy to cover both the distribution headworks scheme and the DLVCS, and make any consequential amendments."**

- 4) Required Amendment 1 (page 10)

Required Amendment 1 has been revised to state that **"Western Power must amend definitions of "headworks" and "headworks scheme" in the Contributions Policy to cover both the distribution headworks scheme and the DLVCS, and make any consequential amendments."**

- 5) Paragraph 68 (page 12)

Paragraph 68 has been deleted. This has consequential effects on the numbering in the remainder of the document.

- 6) Required Amendment 3 (page 12)

Required Amendment 3 has been deleted.

- 7) Paragraph 69 (page 12)

In paragraph 69, **"these"** has been deleted and replaced with **"this"** and **"amendments"** has been deleted and replaced with **"amendment"**.

- 8) Paragraph 74 (page 13)

**"18 May 2012"** has been changed to **"17 April 2012"**. The word **"reduced"** has been deleted and replaced with **"changed"**.

- 9) Footnote 21 (page 13)

**"13 April 2012"** has been changed to **"17 April 2012"**.

- 10) Required Amendment 4 (page 14)

**“Required Amendment 4”** has become **“Required Amendment 3”**.

11) Required Amendment 5 (page 14)

**“Required Amendment 5”** has become **“Required Amendment 4”**.

12) Paragraph 79 (page 14)

**“6.51”** has been changed to **“6.51A”**.
