Newmont Power Pty Ltd

AMENDMENT OF ELECTRICITY DISTRIBUTION LICENCE

The Economic Regulation Authority is seeking public comment on an application by Newmont Power Pty Ltd (**Newmont**) to amend its electricity distribution licence EDL4.

Newmont is seeking to have its electricity distribution licence amended to provide an exemption from having to comply with the *Electricity Industry Customer Transfer Code* 2004 (**Transfer Code**).

Under section 11, Schedule 1(k) of the Act, the Authority may determine the terms and conditions applying to a licence, including requiring the licensee to observe specified codes. Specified codes include any codes issued by the Authority or the Minister for Energy under section 39 of the Act. The Transfer Code is made under section 39 of the Act.

Currently, all electricity licences include a condition (clause 5) requiring licensees to comply with any applicable legislation. Applicable legislation is defined in the licence and includes the Act, regulations and codes that apply to the licensee.

The Authority has interpreted the application submitted by Newmont as being a request to amend the distribution licence to remove the requirement for Newmont to observe the Transfer Code, subject to the condition that there is only one retailer (Newmont) accessing the Newmont distribution system.

Newmont also holds electricity retail licence ERL9. The single customer referred to in the amendment application is supplied under Newmont's retail licence.

Interested parties are invited to make submissions on the proposed amendment by **4:00 pm** (WST) on Friday, 27 July 2012.
