Reason for and Details of the Amendment	<p>Alinta Sales Pty Ltd (Alinta) holds a Gas Trading Licence, GTL9. Alinta seeks two amendments to GTL9.</p> <p>1. Alinta presently has a licence obligation contained in the Compendium of Gas Customer Licence Obligations (Gas Customer Code) in clause 4.1(b) to issue customers with a bill <i>at least every three months</i>.</p> <p>Alinta only receives metering data from WA Gas Networks Pty Ltd (t/a ATCO Gas Australia), the distributor, approximately every 100 days under the Access Arrangement approved by the Economic Regulation Authority. The metering data, provided by ATCO is required to accurately determine a customer's consumption and issue bills for the correct amount.</p> <p>Alinta seeks to amend the licence obligation to allow for bills to be issued not less than every 110 days, in line with the requirements of the distributor to provide the required data to Alinta and to accommodate any delay in receiving the data. The marginal increase in billing frequency will allow for accurate metering data to be received by Alinta from ATCO and enable Alinta to comply with the licence conditions associated with billing cycles.</p> <p>Alinta proposes that an additional licence provision is inserted removing the requirement for Alinta to comply with clause 4.1(b) of the Gas Customer Code and requiring Alinta to issue customers with a bill not more than every 110 days.</p> <p>2. Alinta now trades as Alinta Energy and seeks to amend its Gas Trading Licence to reflect this and incorporate the trading name in the Licence.</p>
