Clause 13.2(a)(i) and 13.2(b)(i) of the amended Compendium require a retailer to keep a record of the total number of, and percentage of, its residential and business customer accounts respectively that have been issued with a bill outside the timeframes prescribed in clause 4.1. This information must be included in the retailer's annual report.	
	Alinta Energy now seeks to amend the licence to remove the requirement to comply with clause 13.2(a)(i) and 13.2(b)(i) of the Compendium and to require Alinta Energy to keep a record and report only the total number of, and percentage of customer accounts that have been issued with a bill outside the 110 day period.
