Consultation Electricity Networks Corporation (t/a Western Power)

CORRECTION TO APPLICATION TO AMEND LICENCE AREA FOR DISTRIBUTION SYSTEM (EDL1)

The Economic Regulation Authority published a notice, dated 31 March 2014, seeking public comment on an application by the Electricity Networks Corporation (t/a Western Power) to extend the licence area identified in Electricity Distribution Licence 1 (EDL1) by 7km southwest of the Mount Gibson goldmine (350km north-east of Perth).

Under the *Electricity Industry Act 2004*, the Authority must not grant a licence amendment unless the Authority is satisfied that it would not be contrary to the public interest to do so.

The Authority has noted an inconsistency in the licence amendment application whereby a small section of the licenced area in the maps provided with Western Power's licence amendment application was incorrect.

The Authority considers the inconsistency does not relate to the area of the proposed licence map amendment and is of minor significance only. Accordingly, the Authority has decided to maintain the due date for public consultation that was stated in the notice dated 31 March 2014.
