## Proposed Revised Access Arrangement for the Mid-West and South-West Gas Distribution Systems

### REVISIONS TO THE PROPOSED REVISED ACCESS ARRANGEMENT

The Economic Regulation Authority (**Authority**) has received ATCO Gas Australia Pty Ltd's (**ATCO's**) response to the Authority's Draft Decision on the proposed revised access arrangement for the Mid-West and South-West Gas Distribution Systems (**GDS**).

ATCO submitted its revisions to the access arrangement for the GDS to the Authority by the close of the extended revision period, 4:00 pm (WST) on Thursday, 27 November 2014. Rule 60 of the National Gas Rules allows ATCO to submit additions or other amendments to its access arrangement proposal to address matters raised in the Authority's Draft Decision. The Authority's Draft Decision detailed reasons why ATCO's proposed revisions to the access arrangement for the GDS were not approved. The Authority outlined 45 amendments it requires to enable it to approve ATCO's proposed revisions to the access arrangement for the GDS.

The documents submitted by ATCO include an updated proposed revised access arrangement, access arrangement information and other supporting information for the GDS. Copies of these documents are available on the [Authority's website](#). ATCO has also provided the Authority with confidential supporting information, which will be assessed by the Authority to determine whether it contains sensitive information that cannot be published.

### PUBLIC SUBMISSIONS

In its notice published on 24 November 2014 which extended ATCO's revision period, the Authority advised that it had extended the public submission period from 4:00 pm (WST) on Tuesday, 23 November 2014 to **4:00 pm (WST) on Monday, 12 January 2015**. Interested parties are invited to make submissions on the Authority's Draft Decision and ATCO's revisions to the proposed revised access arrangement by this closing date.
