DBNGP ACCESS ARRANGEMENT – VARIATION OF REFERENCE TARIFFS FROM 1 JANUARY 2014

The Operator wishes to advise the ERA (in accordance with clause 11.2(e) of the Current Access Arrangement) that, as from 1 January 2014, the Reference Tariffs in the Current Access Arrangement for the DBNGP have been varied for the effects of inflation following the process in clause 11 of the Current Access Arrangement.

As the ERA would be aware:

- clause 11.1(a) of the Current Access Arrangement provides for the Operator's adjustment of the Reference Tariff by way of the CPI Formula Variation;
- clause 11.2(b) of the Current Access Arrangement allows for each Reference Tariff to be varied annually on 1 January of each year of the Current Access Arrangement Period using the CPI Formula Variation;
- clause 11.2(c) of the Current Access Arrangement outlines the formula to be applied.

Accordingly, and pursuant to clause 11.2(e) of the Current Access Arrangement, each of the Reference Tariffs in Clauses 3.3(c), 3.4(c) and 3.5(c) of the Current Access Arrangement were varied on 1 January 2014.

Schedule 1 to this letter details the workings of the CPI Formula Variation for each Reference Tariff, and each of the varied Reference Tariffs, effective from 1 January 2014.
