**DBNGP ACCESS ARRANGEMENT
ACCESS ARRANGEMENT REVISION PROPOSAL**

Revision Proposal Documentation

In accordance with Section 132 of the *National Gas Access (WA) Act 2009 (NGA)* and Rule 52(1) of the National Gas Rules (version 23) (**NGR**), please find enclosed the following documentation filed by DBNGP (WA) Transmission Pty Ltd (**Operator**) as a complying service provider under clause 10(2) of the NGA:

- Proposed Revised Access Arrangement
- Proposed Revised Access Arrangement Information

These documents are attached to the enclosed Submission #1. For the purposes of the NGR, these documents comprise the Access Arrangement Revision Proposal (as that term is defined in the NGR).
