### Proposed Revised Access Arrangement for the Dampier to Bunbury Natural Gas Pipeline

#### INVITATION FOR PUBLIC SUBMISSIONS

The Economic Regulation Authority (**Authority**) is seeking public comment on the proposed revised access arrangement for the Dampier to Bunbury Natural Gas Pipeline (**DBNGP**), available on Authority's <u>website</u>.

On 31 December 2014, DBNGP (WA) Transmission Pty Limited (**DBP**) submitted its proposed revised access arrangement, access arrangement information and other supporting information to the Authority.

The DBNGP is a transmission pipeline which extends approximately 1600 kilometres from Dampier in the Pilbara region, through to Perth and Bunbury in the South West region.

The DBNGP access arrangement sets out the terms and conditions under which DBP will provide third party users access to the DBNGP. The DBNGP access arrangement information and supporting information is provided to help interested parties better understand DBP's proposed revisions.

The National Gas Rules (**NGR**) require that as soon as practicable after receiving a full access arrangement proposal, the Authority must publish an initiating notice on its website and in a newspaper with general circulation around Australia. This notice is published as an initiating notice in accordance with the requirements of the NGR.

The Authority intends to publish an issues paper in March to assist interested parties in preparing submissions on DBP's proposed revisions.

Interested parties are invited to make submissions on the DBNGP access arrangement proposal by 4:00 pm (WST) Monday, 20 April 2015.
