## Consultation on proposed Standard Form Contract

### WESFARMERS KLEENHEAT GAS PTY LTD

The Economic Regulation Authority (**ERA**) is seeking public comment on Wesfarmers Kleenheat Gas Pty Ltd's (**Kleenheat**) [proposed standard form contract](#) for the supply of electricity to small use customers consuming more than 50 MWh per year.

Kleenheat has applied to transfer electricity retail licence 5 (**ERL5**) from Premier Power Sales. ERL5 currently authorises the sale of electricity to large use customers consuming more than 160MWh per year. As part of the transfer application, Kleenheat is seeking to amend the licence to authorise the sale of electricity to contestable customers consuming more than 50 MWh per year. Licence applicants who intend to sell electricity to customers consuming less than 160 MWh of electricity per year must submit with their licence application for the ERA's approval a draft of the standard form contract under which they will supply those customers.

Under the *Electricity Industry Act 2004 (Act)*, the ERA must not approve a standard form contract if it considers the contract does not meet the relevant regulations, the Act, any other written law, or any term, condition or provision of the electricity retail licence.

Interested parties are invited to make submissions on Kleenheat's proposed standard form contract by 4:00pm on **Wednesday, 17 June 2015**.
