**Proposed Revisions to Access Arrangement for the Goldfields Gas Pipeline:
Confidential Information**

Goldfields Gas Transmission Pty Ltd (GGT) submitted amendments to its proposed revisions to the Access Arrangement for the Goldfields Gas Pipeline (GGP Access Arrangement) to the Economic Regulation Authority (ERA) on 29 January 2015. The amendments were made in response to the ERA's 17 December 2015 Draft Decision on GGT's earlier access arrangement revisions proposal.

The amended proposed revised GGP Access Arrangement, and the accompanying Access Arrangement Information, do not contain confidential information and can be published on the ERA's website as part of a public consultation process.

A submission accompanying the amended proposed revised GGP Access Arrangement, and a tariff model, contain confidential information, and should not be published.

To facilitate consultation, GGT has now prepared a "public version" of the submission.

Some of the attachments to the submission contain commercially sensitive information and should continue to be kept confidential by the ERA. The others are not confidential.

GGT has also prepared a public version of the tariff model.
