## Proposed Revised Access Arrangement for the Goldfields Gas Pipeline

### REVISIONS TO THE PROPOSED REVISED ACCESS ARRANGEMENT

The Economic Regulation Authority (**ERA**) has received Goldfields Gas Transmission Pty Ltd's (**GGT**) response to the ERA's Draft Decision on the proposed revised access arrangement for the Goldfields Gas Pipeline (**GGP**).

GGT submitted its revisions to the access arrangement for the GGP to the ERA by the close of the revision period, 4:00 pm (WST) on Friday, 29 January 2016. Rule 60 of the National Gas Rules allows GGT to submit additions or other amendments to its access arrangement proposal to address matters raised in the ERA's Draft Decision. The ERA's Draft Decision detailed reasons why GGT's proposed revisions to the access arrangement for the GGP were not approved. The ERA outlined 22 amendments it requires to enable it to approve GGT's proposed revisions to the access arrangement for the GGP.

The documents submitted by GGT include an updated proposed revised access arrangement, access arrangement information and other supporting information. Copies of these documents are available on the [ERA's website](#). GGT has also provided the ERA with confidential supporting information, which will be assessed by the ERA to determine whether it contains sensitive information that cannot be published.

### PUBLIC SUBMISSIONS

In its notice published on 17 December 2015, the ERA advised that it was allowing a period of at least 20 business days from the end of the revision period stated above for consultation. Interested parties are invited to make submissions on the ERA's Draft Decision and GGT's revisions to the proposed revised access arrangement by **4:00 pm (WST) on Friday, 26 February 2016**.
