EXECUTIVE SUMMARY

In his arbitration practice, Greg has been a practising arbitrator for over 25 years. He is an international arbitrator (a fellow of ACICA) and a grade 1 arbitrator of domestic disputes with IAMA (now Resolution Institute).

In his legal practice, Greg is a partner of international law firm Squire Patton Boggs (Perth office). He brings globally recognised contractual, advisory and dispute resolution expertise to his key role in many of Australia's largest resources, energy and infrastructure projects. He advises energy and resources clients on procurement, works and services contracts and project management. Greg's specific project experience includes Australia's major liquefied natural gas (LNG) and iron ore mining projects. He has advised government authorities as well as leading contractors and consultants on the delivery of public infrastructure including major road, port and rail projects and urban redevelopment. He also has assisted governmental entities and power producers regarding power station construction, operation and maintenance and on electricity supply contracts
