

## INSTRUCTIONS

To obtain a Part 23 (Access to Non-scheme Pipelines) Exemption complete Part A.

If you are the service provider of a non-scheme pipeline that has been granted an Exemption by the Economic Regulation Authority (ERA) and you would like to apply for a variation to a condition of that exemption complete Part B.

If a non-scheme pipeline has been granted an Exemption by the ERA and you would like the exemption to be revoked, complete Part C.

To apply for an Exemption / variation to Exemption / revocation of Exemption:

- 1) Complete relevant Part of application form.
- 2) If the application is made by an authorised agent, proof is required of authority for the agent to act on behalf of the named applicants.
- 3) Attach any additional information/documents that you consider substantiate that the pipeline meets the criteria required for the Exemption. This should include any information or documents required under any Exemption Guideline published by the ERA and in force at the time of the application.
- 4) Complete the Statutory Declaration form below (further information on witnessing documents is available at [www.courts.dotag.wa.gov.au](http://www.courts.dotag.wa.gov.au)).

Application forms (Part A, B or C) including any map showing the location of the pipeline will be included on the ERA's public register. If you provide confidential information in your application, you must also provide a redacted application form that is suitable for publication on the ERA's website ([www.erawa.com.au](http://www.erawa.com.au)).

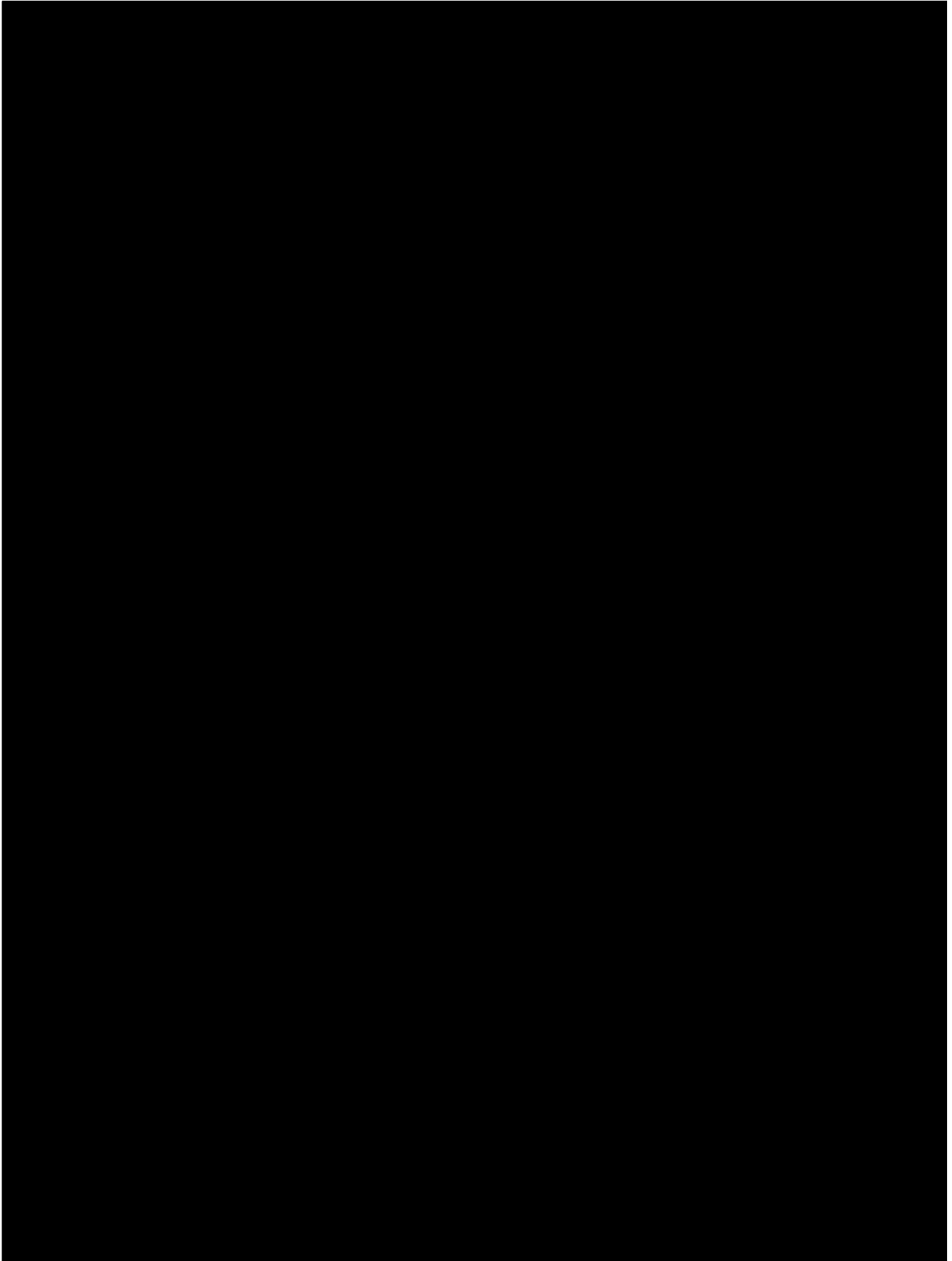

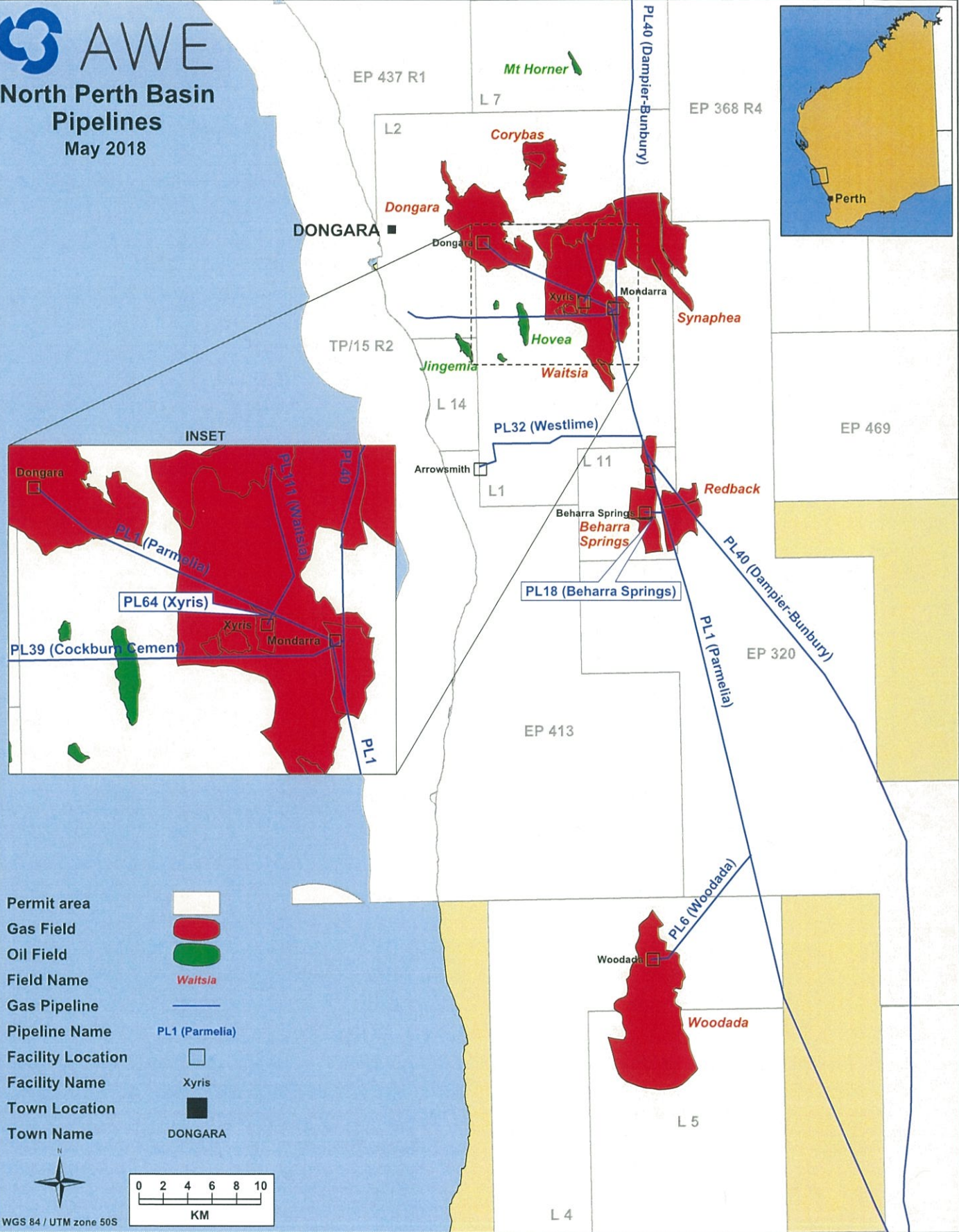

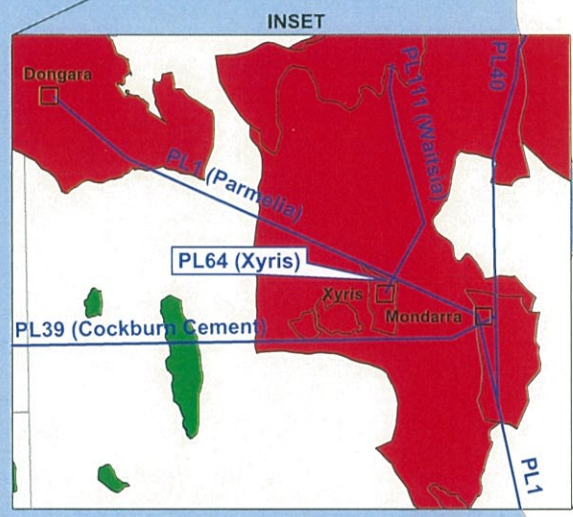
