1. Introduction

ATCO has developed its 2020-24 Plan having regard to the Economic Regulation Authority's (ERA) 2014 Gas Access Arrangement Guideline (the Guideline).

ATCO has sought to balance presenting information in a way that maintains confidentiality, while simultaneously providing stakeholders with enough information to assess issues affecting their interests. Consistent with the Guideline, ATCO has relied on as little confidential information in its 2020-24 Plan as possible, however, at times it was necessary to call upon commercial information to ensure our Access Arrangement Proposal is robust. In these circumstances, ATCO has marked confidential information:

- in documents by redacting confidential information using black highlights; and
- in spreadsheets by removing confidential information.

In some instances, ATCO considers it necessary to claim confidentiality for entire documents or models.

ATCO confirms that we consent to all non-confidential information being disclosed on the ERA's website.
