About the ERA

The ERA is Western Australia's independent economic regulator, established under the *Economic Regulation Authority Act 2003.*

Our role is to regulate the gas, electricity and rail industries, and license providers of gas, electricity and water services. We also conduct inquiries into economic matters referred to us by the State Government, provide support to the independent Rule Change Panel, and have a range of regulatory and review roles in the Wholesale Electricity Market and gas market.

We aim to ensure that the delivery of water, electricity, gas and rail services is in the long-term interests of Western Australians.

Under the ERA's Act, we must consider the following when performing our functions:

- the need to promote regulatory outcomes that are in the public interest
- the long-term interests of consumers in the price, quality and reliability of goods and services
- the need to encourage investment
- the legitimate business interests of investors and service providers
- the need to promote competitive and fair market conduct
- the need to prevent abuse of monopoly or market power
- transparent decision-making processes that involve public consultation.
