3 STATUS REPORT

Mr Rowe spoke to the Status Report, noting the current inquiry into microeconomic reform, the rate of return guidelines for regulated gas pipelines due for release during the month and the report to the Minister for Energy on the wholesale electricity market. Mr Kelly highlighted current customer protection and licensing work by the ERA.

4 GUEST PRESENTATION – The New Water Ombudsman Scheme – Ms Mary White, Principal Assistant Ombudsman. Ms White spoke about the new water industry ombudsman scheme which will come into effect on 1 January 2014. On that date, the existing Energy Ombudsman will be known as the Energy and Water Ombudsman.

5 2014/15 AGENDAS AND MEMBERSHIP RENEWAL

The meeting considered the document Draft ERACCC Forward Agendas 2014-15 circulated by email before the meeting. Mr Rowe called for suggestions for topics for presentations to fill the remaining agenda places. The following topics were proposed:
