1 WELCOME & APOLOGIES

Dr Stephen King chaired the meeting. Dr King noted the apologies as listed above and welcomed members to the fourth meeting of 2014.

2 MINUTES OF MEETING 3/2014 HELD ON 3 September 2014

The minutes were accepted as a true and correct record of the meeting.

3 STATUS REPORT

Dr King spoke to the Status Report and highlighted the following:

- good performance by licensees is being rewarded with extended audit and review periods.
- the GMCCC's review of the Gas Marketing Code recently commenced and a paper will go out for public consultation shortly.
- the Issues Paper for the Prisons inquiry has been released and submissions are encouraged.
- the ERA's role in reviewing the Electricity Generation and Retail Corporation's Regulatory Scheme (i.e. ring-fencing and Chinese walls).
- 4 ERA PRESENTATION Rail Access Arrangements Mr Jeremy Threlfall, Assistant Director Rail, Access, explained the rail regulatory regime and the ERA's role in it. Mr Threlfall noted that there currently are not any third-party access agreements under the rail code, but there are a number of private access arrangements in place.
- 5 GUEST PRESENTATION The Health Department of WA's role in Safe Drinking and Waste Water Services – Mr Richard Theobald, Manager Water Unit, Department of Health provided an overview of the scope of work undertaken by the Department of Health's water unit.

6 ENERGY OMBUDSMAN'S REPORT

The report was taken as read. Mr Marcus Claridge, Director of Energy, Energy Ombudsman briefly highlighted customer complaints trends in electricity, gas and water.

7 ERACCC BIENNIAL SEMINAR – Potential themes/topics

Members brain-stormed a potential topic for the 2015 ERACCC Seminar. Ideas included:

- Communication and technology and how developments affect customers and service delivery. It was suggested that the forum look at both the positives (eg new PPM technology, social media) and negatives (eg. loss of connection, communicating with people who do not have access to technology, communicating with Aboriginal people) to present a balanced view of the advantages yet things that companies must keep in mind to ensure accessibility for all customers.
- The use of social media for dealing with complaints and interacting with customers
- Smart meters/PPMs
- Utilities utilising technology to improve services with customers without leaving people behind.
- How to keep up with methods for the 'Y' generation yet still engage with those who cannot use new technologies, including consideration of accessibility issues for elderly, disabled, non-English speaking, Aboriginal, disadvantaged customers.
- Activity in the national regulation space (i.e. the creation of Energy Consumers Australia).

It was agreed that the theme of the forum should be digital media/social engagement – which notably provides a logical next step from the 2013 topic of engagement to effectively communicating with stakeholders.

Ms Greville requested that members advise her of any ideas for speakers as well as any other presentation topics for consideration.

Minutes Meeting 4 of 2014 – ERACCC – 3 December 2014

Ms Coyne offered to help arrange an Aboriginal elder to conduct the Welcome to Country at the forum.

8 NOMINATION OF MEMBER TO PRESENT AT NEXT MEETING & SUGGESTED PRESENTATIONS FOR 2015

In the interest of time, Dr King advised that this item would be dealt with via email. Ms Greville will contact ERACCC members to seek nominations of a member to present at the March 2015 ERACCC meeting.

9 GUEST PRESENTATION – Cost 'Drivers' of the Retail Electricity Price – Mr Ray Challen, Deputy Director General, Public Utilities Office (PUO) provided a presentation on the cost drivers of WA's electricity prices. Cost drivers include the fact that demand for electricity is no longer growing (for a number of reasons) and there is a lot of reserve capacity (the need for reserve capacity may have been overestimated).

10 MEMBER'S ISSUES & QUESTIONS (Questions on notice) - Ms Irina Cattalini, CEO, WACOSS:

- (a) How consumer interests are being considered in the electricity market review, including how consumers are being supported to participate in the review; and
- (b) Views about the NEM model of industry levy funded consumer representation and advocacy, and the potential for a similar model in the WA market.

Mr Challen responded to the questions on notice. In relation to question (a) he advised that the PUO has had discussions with WACOSS and others for some time on this issue, and that it related to a broader issue surrounding how consumers participate in the debate in what are technically very complex areas.

In relation to question (b), Mr Challen spoke about the establishment of 'Energy Consumers Australia' which will be active from 1 January 2015, and the fact this was set up and funded to represent the consumer in regulatory issues. It was noted of course that this organisation is not active in WA. This was because WA did not want to join based on the cost involved and lack of perceived return on investment. Mr Challen personally agreed it was not worth getting involved at this point, but said that he recognised the need for consumer advocacy. His view is that WA will join that organisation in 2-3 years' time. Mr Brown noted that FCAWA would like to be in that space but does not have the resources to do so without funding. He also noted that the government stopped funding WACOSS' involvement in Code processes a few years ago.

11 CHAIRMAN'S TAKE AWAY & AGREED MESSAGE FOR THE COMMUNIQUE

Dr King thanked Guest Presenters Mr Richard Theobald, Department of Health, and Mr Ray Challen, Public Utilities Office for their presentations, and members for their attendance. He wished everyone a Merry Christmas and a Happy New Year
