Re: Reference Tariff Variation for period beginning 1 January 2020

In accordance with the Revised Access Arrangement approved by the Economic Regulation Authority on 15 November 2019, ATCO Gas Australia (ATCO) has calculated the reference tariffs that will come into effect on 1 January 2020.

The reference tariffs have been calculated by adjusting the tariffs detailed in Annexures A and C of the Revised Access Arrangements into nominal dollar values in accordance with the detailed formulas. ATCO has adopted the following Weighted Average of Eight Capital Cities CPI for the September quarter in these calculations.
