## SUBMISSION OF PROPOSED REVISIONS TO THE ACCESS ARRANGEMENT

I am pleased to provide the Economic Regulation Authority (**ERA**) with Western Power's proposed revisions to its access arrangement for the fifth access period (**AA5 proposal**), covering the period 1 July 2022 to 30 June 2027, as required by the Electricity Networks Access Code 2004. The AA5 proposal is supported by a message from our Chair, Mr Colin Beckett.

Our AA5 proposal has been prepared via the regulatory framework in its current form, including the reforms that have been completed under the State Government's Energy Transformation Strategy (Stage 1).

Western Power proudly connects more than 2 million Western Australians to electricity for their homes, businesses and essential community infrastructure. Western Australians are embracing renewable energy technologies at one of the highest rates in Australia, driving a significant and unprecedented change in the expectations of our transmission and distribution electricity networks.
