I, Rick Fletcher, Executive Director, Fisheries and Agricultural Resource Management of the Department of Primary Industries and Regional Development, in accordance with clause 10 of the *Onslow Prawn Managed Fishery Management Plan 1991* (the Plan), being of the opinion that it is in the better interests of the Fishery, do hereby—

1. Cancel Notice of Areas Closed to Fishing for Prawns in the Onslow Prawn Managed Fishery for 2020; 2021; and 2022: Notice No. 1 of 2020 dated 13 March 2020; and

2. Permit fishing for prawns in all the waters of the “Gear Trial Area” as described in the schedule to this Notice between 0800 hours to 1600 hours each day from 0800 hours 18 March 2023 to 1600 hours 31 March 2023; from 0800 hours 18 March 2024 to 1600 hours 31 March 2024; and from 0800 hours 18 March 2025 to 1600 hours 31 March 2025; and
3. Permit fishing for prawns in all waters of the Onslow Prawn Managed Fishery (the Fishery), as described in the Plan and in the schedule to this Notice from 0800 hours 1 April 2023 to 0800 hours 30 October 2023; from 0800 hours 1 April 2024 to 0800 hours 30 October 2024; and from 0800 hours 1 April 2025 to 0800 hours 30 October 2025, except for those parts of the Fishery between the times and dates provided for in paragraphs (a) to (e) below—
 - (a) fishing for prawns is prohibited from the date of this Notice in—
 - (i) all the waters of the “New Coolgra Nursery” as described in the schedule to this Notice;
 - (ii) all the waters of the “New Port of Onslow” as described in the schedule to this Notice; and
 - (iii) all the waters of the “New Port of Dampier” as described in the schedule to this Notice.
 - (b) fishing for prawns is prohibited from 0800 hours 1 April 2023 to 0800 hours 3 May 2023; from 0800 hours 1 April 2024 to 0800 hours 3 May 2024; and from 0800 hours 1 April 2025 to 0800 hours 3 May 2025 in—
 - (i) all the waters of the “Ashburton Prawn Size Management Fish Ground” as described in the schedule to this Notice;
 - (ii) all the waters of the “Weld Island Prawn Size Management Fish Ground” as described in the schedule to this Notice; and
 - (iii) all the waters of the “Mangrove Island Prawn Size Management Fish Ground” as described in the schedule to this Notice.
 - (c) fishing for prawns is prohibited from 0800 hours 1 April 2023 to 0800 hours 30 May 2023; from 0800 hours 1 April 2024 to 0800 hours 30 May 2024; and from 0800 hours 1 April 2025 to 0800 hours 30 May 2025 in—
 - (i) all the waters of the “Fortescue Prawn Size Management Fish Ground” as described in the schedule to this Notice;
 - (d) fishing for prawns is prohibited from 1800 hours to 0600 hours the following day from 0800 hours 3 May 2023 to 0600 hours 1 October 2023; from 0800 hours 3 May 2024 to 0600 hours 1 October 2024; and from 0800 hours 3 May 2025 to 0600 hours 1 October 2025 in—
 - (i) all the waters of the “Ashburton Prawn Size Management Fish Ground” as described in the schedule to this Notice.

WESTERN AUSTRALIAN MARINE ACT 1982**CLOSURE OF NAVIGABLE WATERS ORDER****Wing in Ground Effect Operations**

Pursuant to the power in section 66 of the *Western Australian Marine Act 1982*, I close the following areas of navigable waters to the operation of wing-in-ground effect craft, when operating in ground effect mode—

1. All gazetted closed waters areas or swimming prohibited areas;
2. All protected waters;

With the exception of vessels listed in schedule A which may operate in the waters of Schedule B, in accordance with the Operating Conditions of Schedule C.

In this notice, the following definitions apply—

Wing-in-ground effect craft means a multimodal craft which, in its main operational mode, flies by using ground effect above the water, without constant contact with such a surface and supported in the air, mainly, by an aerodynamic lift generated on a wing (wings), hull, or their parts, which are intended to utilise the ground effect action.

Wing-in-ground effect craft operator means the person who is the driver, master, owner, possessor, skipper, or user of the vessel or the person causing, permitting, or suffering the vessel to be navigated;

Ground effect mode means the steady state operational mode of operating the craft in ground effect above water.

Launch site means the location that the wing-in-ground effect craft was launched into the water from.

Water skiing means the sport or exercise of being towed over water, at a speed of 8 knots or more, by a motor boat, so as to be supported on the surface by a ski or skis, an aquaplane or other apparatus, or the feet.

Waters has the same meaning as in section 66(5) of the *Western Australian Marine Act 1982*.

Protected Waters has the same meaning as in Regulation 2 of the *Navigable Waters Regulations 1958*.

SCHEDULES**SCHEDULE A—**

Registered vessel—GW698

SCHEDULE B—

1. All those waters of the Swan and Canning Riverpark.
2. Navigable Waters which permission has been granted under Regulation 51C of the *Navigable Waters Regulations 1958* to hold a race, display, regatta or exhibition for wing-in-ground effect craft.

SCHEDULE C: Operating Conditions

1. Only one person is to operate the wing-in-ground effect craft at any one time;
2. The wing-in-ground effect craft operator must—
 - a. be at least 18 years of age;
 - b. hold a Recreational Skippers Ticket as per regulation 47 of the *Navigable Waters Regulations 1958*;
 - c. not operate the craft in ground effect mode within 50 metres of any other vessel, a person in the water or a person water skiing;
 - d. not exceed a gazetted speed restriction;
3. The wing-in-ground effect craft must—
 - a. be appropriately registered for operation in Western Australia as per regulation 45B of the *Navigable Waters Regulations 1958*;
 - b. only be operated between sunrise and sunset, unless operating in an aquatic event approved under Regulation 51C of the *Navigable Waters Regulations 1958*;
4. During operation, the operator of a vessel nominated in Schedule A must display signs at the launch site notifying other water users that a wing-in-ground effect craft is in operation;
5. If ownership of the vessel nominated in Schedule A is transferred after publication of this notice, approval to operate in the waters of Schedule B no longer applies;

6. General safety obligations, collision regulations and any other legislative requirements that apply to a recreational vessel under the *Navigable Waters Regulations 1958* and *Western Australian Marine Act 1982* must be complied with at all times.

This notice is valid from the date of publication.
