Call for Submissions:

Best Practice Utility Licensing

The Economic Regulation Authority, as the regulator responsible for administering the utility licensing schemes, is seeking public comments on a "Best Practice Utility Licensing" paper.

The Authority seeks to adopt the principles of best practice utility licensing and is seeking comments from interested parties on the licensing principles proposed in this paper, as follows:

- Maintaining service standards A licensing regime should include processes that
 maintain the licensee's focus on service standards to customers. To achieve this, the
 Authority seeks to ensure that its processes are consumer focused, consistent across
 industries and based on consultation with consumer representatives.
- Minimising regulatory risks To minimise regulatory risk, the Authority seeks to ensure that its decisions are predictable, consistent, timely, transparent and based on effective consultation.
- Minimising compliance costs A licensing regime should aim to achieve its policy objectives at least cost to the licensee. To minimise compliance costs, the Authority seeks to ensure that its processes use simple and targeted language, are consistent with other laws and integrated across jurisdictions, are flexible, and are formulated with input from interested parties. Also, licensing requirements should be proportionate to the problems that exist, not unduly prescriptive and the minimum necessary to achieve the objective.
