NOTICE WESTERN AUSTRALIAN GAS REVIEW BOARD APPEALS 1, 2, 3 AND 4 OF 2004

By a decision dated 30 December 2003, the Western Australian Independent Gas Pipelines Access Regulator ("the Regulator") approved his own access arrangement for the Dampier to Bunbury natural gas pipeline ("DBNGP") ("the Decision") owned by Epic Energy (WA) Nominees Pty Ltd (ACN 081 609 289) (Receivers and Managers Appointed) (Administrators Appointed) and Epic Energy (WA) Transmission Pty Ltd (ACN 081 609 190) (Receivers and Managers Appointed) (Administrators Appointed) (together referred to as "Epic"). The Decision was amended on 12 January 2004. On 14 January, Epic, Western Power Corporation and North West Shelf Gas Pty Ltd lodged applications for review of certain aspects of the Decision ("the Appeals") with the Western Australian Gas Review Board (the "GRB").

Copies of the Appeals lodged by Epic and Western Power Corporation have been posted to the Economic Regulation Authority of Western Australia website at www.era.wa.gov.au and can be accessed at that site. The Appeal lodged by North West Shelf Gas Pty Ltd seeks an order from the GRB varying the Decision so that the access arrangement governing the DBNGP provides for a maximum inlet temperature for gas at receipt point I1-01 on the DBNGP of 60 degrees Celsius rather than 50 degree Celsius. The Appeal lodged by North West Shelf Gas Pty Ltd has not been posted on the ERA website. Persons wishing to obtain a copy of the Appeal lodged by North West Shelf Gas Pty Ltd should make an application to the Registrar of the Gas Review Board (whose contact details are set out below).

The Appeals will be heard by the GRB in October and November 2004. Programming orders have been made in relation to the Appeals and can be accessed at the ERA website.

Those persons who wish to claim a right to be heard by the GRB in relation to the Appeals should forward an application within 21 days of the date of this notice to the GRB setting out in detail:

- (a) how that person's interests are said to be affected by a particular Appeal; and
- (b) the grounds said to give rise to a right to make submissions to the GRB in relation to a particular Appeal.

Applications received after 21 days from the date of this notice may be not be considered by the GRB.
