# EXTENSION OF TIME FOR PUBLIC SUBMISSIONS ALINTAGAS ACCESS ARRANGEMENT FOR MID AND SOUTH WEST GAS DISTRIBUTION NETWORKS

This is to advise that a further extension of time has been granted to allow sufficient time for parties to make submissions in respect of the proposed Access Arrangement and Access Arrangement Information for the AlintaGas Mid-West and South-West Gas Distribution Networks.

Given that a number of requests have been received for an extension of time raising issues only recently identified and considering the detailed nature of the proposed AlintaGas Access Arrangement, it is considered appropriate that a further extension of time for submissions be provided.

The closing date for submissions was subsequently extended to 4 pm Thursday 19 August 1999.
