## CORRIGENDA FOR DRAFT DECISION DAMPIER TO BUNBURY NATURAL GAS PIPELINE

The Western Australian Independent Gas Pipelines Access Regulator, Dr Ken Michael, issued his Draft Decision on 21 June 2001 on the proposed Access Arrangement for the Dampier to Bunbury Natural Gas Pipeline (DBNGP), lodged on 15 December 1999 by Epic Energy (WA) Transmission Pty Ltd (Epic Energy).

A number of printing revisions have been identified and are listed below.

- 1. Part A page 7 and Part B page 54, Amendment 14 lines 2 and 3 amend words "the shipper" to read "that shippers".
- 2. Part A page 41 and Part B page 265 incremental charges for Compression Capacity to be revised as follows:

Revised Compression Capacity Charges expressed as increments for each compressor station with straight-line depreciation (1 July 2000 GJMDQ, excluding goods and services tax)

- 6. Part A page 44 and Part B page 268:
  - Amend Zone 7 total tariff from \$0.6344/GJ to \$0.6324/GJ.
  - Amend Zone 10 (Kwinana) total tariff from \$0.8454/GJ to \$0.8455/GJ.



- 7. Part B page 152, second paragraph line 4 delete the word "be".
- 8. Part B page 184, footnote 199 renumber paragraphs to "(1)" and "(2)" respectively.
