Scope and purpose of the corrigenda

The Economic Regulation Authority (**Authority**) published the 2005/06 Annual Report – Code of Conduct (For the Supply of Electricity to Small Use Customers) (**Annual Report**) on 24 April 2007.

The Annual Report details the performance of electricity retailers who supply electricity to small use customers in respect of the matters dealt with in Part 13, Division 2 of the *Code of Conduct (For the Supply of Electricity to Small Use Customers)* (**Code of Conduct**).

In relation to Part 13, Division 2 of the Code of Conduct the following matters have come to the attention of the Authority:

- Records provided to the Authority by Landfill Gas and Power should not have been included in the report as these records do not relate to small use customers as defined in the Code of Conduct.
- Records to be kept in respect of Part 13.2 of the Code of Conduct (Affordability and access) apply to all small use customers. The Annual Report only provided information in respect of those records relating to small use residential customers.

This corrigenda amends the Annual Report to deal with the matters identified above. The amendments are described in the following section.

Amendments to the Annual Report

It is important to note that the amendments made to the report do not materially affect the reported performance of electricity retailers. The amendments to the annual report are described in the following paragraphs.

- 1) Page 4 – Landfill Gas and Power has been removed from the bulleted list at the bottom of the page.
- 2) Page 10 – Customer data for Landfill Gas and Power has been removed from Table 2.
- 3) Page 11 – The second paragraph and bulleted list has been replaced with the following text:

“The following retailers have reported they supply small use customers but have a nil return in respect of affordability and access performance indicators:

 - Alinta Sales Pty Ltd
 - Perth Energy Pty Ltd
 - Rottnest Island Authority”
- 4) Page 11 – Data related to Rottnest Island Authority has been removed from Table 3.
- 5) Page 13 - Data related to Rottnest Island Authority has been removed from Table 4.

- 6) Page 14 - Data related to Rottnest Island Authority has been removed from Table 5.
 - 7) Page 15 - Data related to Rottnest Island Authority has been removed from Table 7.
 - 8) Page 17 – Data related to Landfill Gas and Power has been removed from Table 8.
