Scope and purpose of the corrigenda

The Economic Regulation Authority (**Authority**) published the Electricity Compliance Reporting Manual (**Manual**) on 25 May 2007.

The Authority published the Manual in order to provide:

- A consolidated list of the terms and conditions of each type of electricity licence to assist licensees with identifying the compliance obligations relevant to the licence(s) they have been granted;
- Categorisation of licence conditions to assist with reporting obligations;
- A self-assessment framework for licensees to facilitate compliance with licence conditions and report non-compliance to the Authority on a self-reporting basis; and
- The reports that licensees must provide to the Authority and the timing of these reports.

Section 12 of the Manual sets out the compliance reporting obligations applicable to electricity distribution and retail licences in respect of the Code of Conduct (for the Supply of Electricity to Small Use Customers) 2004 (**2004 Code**).

Section 16 of the Manual sets out the performance reporting obligations applicable to electricity distribution and retail licences in respect of the 2004 Code.

The Electricity Code of Conduct Consultative Committee (**ECCC**) completed its review of the 2004 Code in September 2007¹. The Authority repealed the 2004 and replaced it with the Code of Conduct (for the Supply of Electricity to Small Use Customers) 2008 (**2008 Code**) on 8 January 2008. The Authority has also published a Correction in the Government Gazette (Gazette), dated 26 February 2008, to address minor errors in the 2008 Code.

The Authority has updated the Manual to align with the compliance reporting obligations and record keeping obligations in the 2008 Code, inclusive of the corrections published in the Gazette.

The Authority has decided to remove reporting of performance against service standard benchmarks related to the Western Power Access Arrangement from the Manual.

The Authority has also taken the opportunity to make further amendments to the performance reporting obligations for distribution and retail licensees based on the experience gained from the first round of reports in 2007.

The amendments to the Manual described in this Corrigenda fall into 4 categories:

- (1) Amendments to section 6 (Type 1 reporting obligations for all licence types) to incorporate new Type 1 reporting obligations in the 2008 Code.
- (2) Amendments to section 12 (Code of Conduct licence conditions and obligations) to reflect the obligations in the 2008 Code.

- (3) Amendments to section 16 (Performance reporting obligations) to incorporate the performance reporting obligations for distribution and retail licensees in the 2008 Code.
- (4) Miscellaneous amendments to the Manual to remove redundant provisions, restructure the document to improve legibility and include other obligations and provisions that are not directly related to the 2008 Code.

The amendments to the Manual have been carried out in the order that they appear in the above list. This means that the section numbering referred to in items 1-3 above relates to the original Manual published in May 2007. When item 4 has been completed the section numbering in the Manual is revised so that, for example, section 12 is renumbered to section 14.
