## **Invitation for Public Submissions**

## Review of the Weighted Average Cost of Capital to Apply to the Urban and Freight Rail Networks

The Economic Regulation Authority has released its draft determination for the 2008 Weighted Average Cost of Capital (WACC) for the railway infrastructure associated with the urban and freight rail networks.

The Authority is inviting public submissions on the draft determination, which set the 2008 real pre-tax WACC values at:

- 9.30 per cent for the freight network; and
- 7.17 per cent for the urban network.

The draft determination is available on the Authority's web site.

## **Background**

The Railways (Access) Code 2000 (Code) requires the Authority to make an annual determination, as at 30 June, of the WACC to be applied in calculating the floor and ceiling costs for each of the urban and freight rail networks covered under Schedule 1 of the Code.

The Code also requires that, from 2003, the Authority undertakes public consultation every fifth year before determining the WACC values for that year. Consequently, the Authority must consult the public before determining the WACC for the 12 months from 1 July 2008.

The Authority commenced the public consultation process for its 2008 WACC review in October 2007 with the release of a report by the Allen Consulting Group (ACG). Four submissions - from Synergies Economic Consulting, Alcoa World Alumina Australia, the Chamber of Commerce and Industry of Western Australia and the Australian Pipeline Industry Association - were received.

The Authority considered the four submissions in preparing its draft determination.

### **Public Submissions**

All submissions should be in electronic and hard copy form and must be received by **4.00pm** (Western Standard Time) on Friday 2 May 2008.
