# Electricity Networks Access Code 2004 Draft Access Arrangement Information Guidelines

### **INVITATION FOR SUBMISSIONS**

The Economic Regulation Authority has invited comments from interested parties on its draft access arrangement information guidelines, which the Authority has prepared under the *Electricity Networks Access Code 2004*. A copy of the access arrangement information guidelines can be obtained from the Authority's <u>web site</u>.

Under section 4.5 of the Access Code, the Authority may publish guidelines that provide details on what must be included in access arrangement information so that it complies with the Access Code.

Access arrangement information must enable the Authority, users and applicants to understand how the service provider derived elements of its proposed access arrangement (or revisions to its approved access arrangement) and form an opinion on whether the access arrangement complies with the Access Code.

#### INVITATION TO MAKE A SUBMISSION

Interested parties are invited to make submissions to the Authority by 4pm (WST) Tuesday, 17 June 2008.

The Authority will consider these submissions before publishing final access arrangement information guidelines by 1 July 2008.
