Invitation for public submissions on the draft determination on the weighted average cost of capital for The Pilbara Infrastructure's Railway

The Economic Regulation Authority has released its draft determination for the 2009 weighted average cost of capital (WACC) for the Pilbara railway built and operated by The Pilbara Infrastructure Group (TPI), a subsidiary of Fortescue Metals Group Ltd.

The Authority is inviting public submissions on the draft determination, which proposes a 2009 real pre-tax WACC value of 10.25 per cent.

The draft determination is available on the Authority's web site.

Background

The *Railways (Access) Code 2000* requires the Authority to make an annual determination of the WACC to be applied in calculating the floor and ceiling costs for rail networks covered under the code.

On 4 September 2008, the Authority published an issues paper and invited submissions from interested parties. The Authority also commissioned a report by CRA International to provide advice on the TPI WACC. The Authority considered all the information provided in the preparation of its draft determination.

The <u>public submissions</u> received on the Authority's issues paper and the <u>draft CRA report</u> are available on the Authority's web site.

The Authority will issue its final determination on or before 30 June 2009.
