### INVITATION FOR PUBLIC SUBMISSIONS

# APPLICATION TO AMEND ELECTRICITY INTEGRATED REGIONAL LICENCE 2 – HORIZON POWER

The Economic Regulation Authority is seeking public comment on an application by Horizon Power to amend its Electricity Integrated Regional Licence 2.

Horizon Power is proposing:

- a change of address to Stovehill Road, Karratha;
- to delete map references to power stations in seven licensed areas Broome, Camballin, Coral Bay, Denham, Derby, Exmouth, Fitzroy Crossing, Halls Creek and Hopetoun;
- to include a reference to power stations in two licensed areas Kununurra and Wyndham;
- to amend its installed capacity to 40.604 MW;
- to amend the definition of 'individual performance standard' to refer to clause 25; and
- to amend the definition of 'licence' part '(c)' to refer to clause 25.

A copy of the company's <u>letter of request</u> and <u>associated maps</u> can be obtained from the Authority's web site.

Submissions on the licence amendments are invited from all interested parties and must be received by **4.00pm Tuesday**, **14 April 2009 WST**. Submissions should be in both written and electronic format and directed to:
