Further Invitation for Public Submissions

APPLICATION TO AMEND ELECTRICITY TRANSMISSION LICENCE 2 AND ELECTRICITY DISTRIBUTION LICENCE 1

The Economic Regulation Authority is seeking further public comment on an application by Western Power to amend its distribution and transmission licences.

Western Power has revised its original request to remove the requirement to have its trouble call fault management plan approved by the Authority. It is now seeking to replace clause 22 of Electricity Transmission Licence 2 and clause 25 of the Electricity Distribution Licence 25 with the following.

1. The licensee will operate and maintain a trouble call fault management system.
2. The licensee must provide prior notification to the Authority if it intends to outsource its trouble call fault management system.

Submissions on the licence amendment are invited from all interested parties and must be received by **4.00pm Wednesday 23 September 2009 WST**. Submissions should be in both written and electronic format and directed to:
