### Invitation for Submissions on Proposed Additional Revision to Pricing Years

#### WESTERN POWER'S PROPOSED ACCESS ARRANGEMENT REVISIONS

On 10 September 2009, Western Power made a submission to the Economic Regulation Authority in response to the Authority's draft decision on its proposed access arrangement revisions.

In this submission, Western Power proposes revisions to the periods for which price lists will be submitted during the second access arrangement period. Western Power proposes to amend sections 3.8 to 3.10 of the proposed access arrangement revisions to set out the start and end dates of each pricing year as follows:

Pricing Year	Start Date	End Date
1	<i>Start date of the amended proposed access arrangement revisions</i>	30 June 2010
2	1 July 2010	30 June 2011
3	1 July 2011	30 June 2012

Western Power's proposal is outlined in section 2.4.3 of its [submission](#), with further details contained in Attachment O of the submission.

Western Power's proposal to amend the start and end dates of each pricing year has not yet been considered by the Authority, and will be considered as part of its final decision on Western Power's proposed access arrangement revisions.

The Authority issued its draft decision on Western Power's proposed access arrangement revisions on 16 July 2009. Submissions on the draft decision closed 10 September 2009 and are available from the Authority's [web site](#).
