Proposed Revisions to WestNet Rail's Segregation Arrangements

The Economic Regulation Authority has invited submissions on [proposed revised Segregation Arrangements](#) submitted by WestNet Rail on 6 October 2009.

A railway owners' Segregation Arrangements set out the controls and procedures for segregating its access-related functions from its other functions, which is a requirement under Part 4 of the *Railways (Access) Act 1998*.

WestNet Rail's proposed revised Segregation Arrangements incorporate a manual of segregation arrangement compliance procedures as an appendix (Appendix A).

The proposed revised Segregation Arrangements, including a marked-up version showing the changes, are available from the Authority's [web site](#). Appendix A has not previously been released publicly and is therefore not provided as a marked up document.

Interested parties are invited to make submissions in printed and electronic form on the proposed revision to WestNet Rail's Segregation Arrangements by **4:00pm (WST) on Wednesday, 25 November 2009**.
