Dampier to Bunbury Natural Gas Pipeline

ANNUAL REFERENCE TARIFF VARIATION 2010

The Economic Regulation Authority has allowed a variation to the reference tariffs for the Dampier to Bunbury Natural Gas Pipeline (**DBNGP**). The variation was proposed by DBNGP (WA) Transmission Pty Limited (**DBP**) on 18 December 2009. A copy of DBP's proposal can be viewed on the Authority's <u>web site</u>.

The variation increases the reference tariffs by the Consumer Price Index (All Groups - Perth), which is consistent with the tariff variation procedure set out in the revised access arrangement which came into effect on 30 December 2005. The CPI increase was 1.20% on the previous period.

The reference tariffs for part haul (P1) and back haul (B1) services are distance based and determined as a proportion of the reference tariff for the full haul (T1) service. This proportion is based on the distance the shipper is transporting the gas along the pipeline (from the inlet point to the outlet point) compared with the total length of the pipeline, as set out under section 3.2 of the access arrangement information.

The commencement date of the variation is in accordance with section 8.3D of the National Third Party Access Code for Natural Gas Pipeline Systems, which requires that the variation comes into effect 35 days after the date of the notice from the service provider. This means that the reference tariff variation comes into effect on 22 January 2010.

The table attached to this notice shows DBNGP reference tariffs for 2010.
