Invitation for Public Submissions

FINANCIAL HARDSHIP POLICY GUIDELINES

The Economic Regulation Authority is seeking public comment on amendments to the Financial Hardship Policy Guidelines.

From 1 July 2010, the Code of Conduct for the Supply of Electricity to Small Use Customers and the Compendium of Gas Customer Licence Obligations (Gas Customer Code) will be amended to require that electricity retailers and gas traders review their financial hardship policy at least annually. The results of any review must be submitted to the Authority within 5 business days after it is completed.

The Codes will require that any review of a retailer's hardship policy must have regard to the Authority's Financial Hardship Policy Guidelines. Upon receipt of a retailer's hardship policy, the Authority will assess whether the review was undertaken consistently with the guidelines. The Authority will also examine whether the hardship policy complies with the Code requirements.

The Financial Hardship Policy Guidelines were originally published by the Authority in August 2008. A copy of the amended Guidelines is available on the Authority's <u>website</u>.

Interested parties are invited to make submissions in print and electronic form by **4:00 pm** (WST) on Wednesday, 14 July 2010.
