Disclosure of information under the National Gas Access Act (WA) 2009

PROPOSED REVISED ACCESS ARRANGEMENT FOR THE DAMPIER TO BUNBURY NATURAL GAS PIPELINE

The Economic Regulation Authority has today published two submissions from DBNGP (WA) Transmission Pty Ltd (**DBP**) on its <u>website</u>:

- DBP, 6 August 2010, Submission 26: Response to 3rd Party Submissions
- DBP, 11 August 2010, Submission 27: Response to Rio Tinto Submission.

In deciding to publish these submissions, the Authority has decided to disclose some information in Submission 26 that DBP has claimed to be confidential. This disclosure decision has been made pursuant to section 329 of the Western Australian National Gas Access Law (**NGL(WA)**), as implemented by the *National Gas Access (WA) Act 2009*.

A summary of the information the Authority agrees should remain confidential is included in <u>Schedule 1</u> of this notice.

BACKGROUND

Notice of disclosure

Pursuant to section 329(2) of the NGL(WA), on 14 September 2010, the Authority issued an *Initial Disclosure Notice* to DBP giving notice of the Authority's intention to disclose information in Submission 26 that DBP claimed to be confidential. Pursuant to section 329(3), separate disclosure notices were issued to three additional parties, being persons from whom DBP received information which DBP claimed to be confidential.

All parties were given until 5:00 PM (WST) Tuesday, 21 September 2010 to make representations to the Authority not to disclose the information in question. DBP was the only party who made representations to the Authority.

The Authority considered DBP's representations. On 26 October 2010, the Authority issued a *Further Disclosure Notice* to DBP pursuant to section 329(6) of the NGL(WA) giving notice of the Authority's intention to disclose certain information in Submission 26 that DBP claimed to be confidential.

Pursuant to section 329(1), the Authority is authorised to disclose the information the subject of the *Further Disclosure Notice* 5 business days after the *Further Disclosure Notice* was provided to DBP.
