Invitation for Public Submissions

WESTERN POWER'S MID-WEST ENERGY PROJECT (SOUTHERN SECTION)

The Economic Regulation Authority is seeking public comment on Western Power's proposed Mid-West Energy Project (Southern Section); a major augmentation that has been submitted to the Authority under Chapter 9 of the *Electricity Networks Access Code 2004* (**Access Code**) for a determination on whether it satisfies the Regulatory Test. The proposed augmentation involves the construction of a 330 kV transmission line from Neerabup to Karara Mining Ltd's iron ore mine site via Eneabba and the interconnection of the existing 132 kV Three Springs substation with a new 330 kV Three Springs Terminal.

The Regulatory Test is an assessment of whether a proposed major augmentation maximises the net benefit to those who generate, transport and consume electricity in Western Power's covered network and any interconnected system, after considering alternative options.

Issues Paper

The Authority has prepared an <u>issues paper</u> to assist interested parties prepare submissions. This paper is not intended to be an exhaustive review of Western Power's major augmentation proposal at this point in time, or the matters that the Authority will address when making its decision on the application.
