## Wesfarmers Kleenheat Gas Pty Ltd

### LICENCE RENEWAL APPLICATION – GAS TRADING LICENCE 10

The Economic Regulation Authority is seeking public comment on the application by Wesfarmers Kleenheat Gas Pty Ltd (**WKG**) to renew its gas trading licence. WKG supplies gas in Margaret River and Oyster Bay in Albany, which are located in the Coastal and Great Southern Gas Supply Areas.

Under the *Energy Coordination Act 1994*, the Authority is responsible for licensing gas supply services in Western Australia and must take all reasonable steps to decide on an application within 90 days of it being submitted.

The issuing of a licence is subject to the Authority being satisfied that it would not be contrary to the public interest to do so and the applicant:

- a) has, and is likely to retain; or
- b) will acquire within a reasonable time after the grant, and is then likely to retain,

the financial and technical resources to undertake the activities authorised by the licence.

Interested parties are invited to make submissions in print and electronic form on the renewal application by **4:00 pm (WST) on Wednesday, 10 August 2011**.
