Compendium of Gas Customer Licence Obligations

PROPOSED AMENDMENTS

The Economic Regulation Authority is seeking public comment on proposed amendments to the Compendium of Gas Customer Licence Obligations (**Compendium**).

The Compendium contains licence conditions made by the Authority under section 11(M)(1) of the *Energy Coordination Act 1994*. The Compendium forms Schedule 2 of gas trading and gas distribution licences.

The Authority introduced these conditions in 2009 to ensure that gas customers received, where possible, protection equal to that provided for electricity customers under the *Code of Conduct for the Supply of Electricity to Small Use Customers* (**Electricity Code**).

Following the 2011 review of the Electricity Code, the Authority approved a new Electricity Code that will come into effect on 1 January 2013.

To ensure that customer protections remain as consistent as possible across the electricity and gas industries, the Authority now proposes similar amendments be made to the Compendium.

The proposed amendments also include changes to the title of the Compendium, the dual fuel contracts clause, limitations on disconnection and some definitions.

The Authority does not propose any amendments related to gas marketing provisions as these issues will be dealt with by the Gas Marketing Code Consultative Committee review of the Gas Marketing Code of Conduct, due to commence in 2013.
