# Guidelines for the Rate of Return for Gas Transmission and Distribution Networks

#### INVITIATION FOR SUBMISSIONS

The Economic Regulation Authority has today published on its website a <u>consultation paper</u> on guidelines for the rate of return for gas transmission and distribution networks.

Under the Australian Energy Market Commission's recent changes to the National Gas Rules, the Authority is required to produce rate of return guidelines at least every three years. The first rate of return guidelines must be finalised and published by the Authority by 29 November 2013.

The guidelines provide an opportunity to undertake a comprehensive review of approaches for determining the rate of return on capital for regulated gas transmission and distribution in Western Australia.

The Authority intends consulting stakeholders as part of the development of the proposed rate of return guidelines. The initial consultation is underpinned by the consultation paper. The consultation paper sets out the Authority's:

- understanding of the requirements for developing the rate of return guidelines, and its broad approach to meeting those requirements;
- proposed process and timeline for consulting with stakeholders on the development of the rate of return guidelines; and
- identification and preliminary assessment of the range of additional options to be evaluated in the review.

The Authority will also conduct workshops and other consultations as required. The need for such additional consultation will be determined on an as needed basis.
