# Alinta Sales Pty Ltd (t/a Alinta Energy)

## AMENDMENT OF GAS TRADING LICENCE

The Economic Regulation Authority is seeking public comment on an application by Alinta Sales Pty Ltd (t/a Alinta Energy) (**Alinta**) to amend its gas trading licence GTL9.

Gas retailers are required by the *Compendium of Gas Customer Licence Obligations* (**Compendium**) to issue bills to customers not more than once a month, or at least once every three months, unless the specified exemptions apply.<sup>1</sup>

On 17 September 2012, the Authority approved an amendment to Alinta's gas trading licence, allowing Alinta to issue a bill at least once every 110 days instead of the three month period specified in the Compendium. The billing frequency specified in Alinta's licence now aligns with the frequency by which Alinta receives metering data from its distributor.<sup>2</sup>

Alinta is currently required by the Compendium to keep records and report on the total number of, and percentage of, residential and business customer accounts that have been issued with bills more than once a month or greater than three months.<sup>3</sup> Therefore, while Alinta's billing cycle has been increased to 110 days, its recording and reporting obligations related to the issuance of bills are based on the standard three month billing cycle.

Alinta now seeks to keep records and report only on the total number of, and percentage of residential and business customer accounts that have been issued with a bill outside of the 110 day period, instead of the three month period specified in the Compendium.

Alinta also seeks to remove the requirement to record and report on the total number and percentage of both residential and business customer accounts that have been issued with a bill greater than once a month.

Interested parties are invited to make submissions on the proposed amendment by **4:00 pm** (WST) on Friday, 1 March 2013.
