## Guidelines for the Rate of Return for Gas Transmission and Distribution Networks

### INVITATION FOR SUBMISSIONS

The Economic Regulation Authority today has published on its website the **Draft Rate of Return Guidelines** and the **Explanatory Statement for the Draft Rate of Return Guidelines**. These documents set out the Authority's proposed approach under the National Gas Rules for determining the rate of return for gas transmission and distribution networks.

Under the Australian Energy Market Commission's recent changes to the National Gas Rules, the Authority is required to prepare rate of return guidelines at least every three years.<sup>1</sup> The first rate of return guidelines must be finalised and published by the Authority by 29 November 2013.

The guidelines development process provides an opportunity to undertake a comprehensive review of approaches for determining the rate of return on capital for regulated assets owned by gas transmission and distribution businesses in Western Australia.

As part of its consultation process to this point, the Authority has published an Issues Paper in December 2012, released a Working Paper on the Cost of Debt in June 2013, and held a workshop with stakeholders in July 2013. The Authority will continue to engage stakeholders to obtain input to the development of the rate of return guidelines.
