Proposed Revised Access Arrangement for the Dampier to Bunbury Natural Gas Pipeline

PUBLICATION OF ISSUES PAPER

The Economic Regulation Authority (**ERA**) has published an [issues paper](#) on the proposed revised access arrangement for the Dampier to Bunbury Natural Gas Pipeline (**DBNGP**).

On 31 December 2014, DBNGP (WA) Transmission Pty Limited (**DBP**), as the complying service provider of the DBNGP, submitted proposed revisions to the DBNGP access arrangement to the ERA.

We issued an initiating notice on 11 February 2015 advising of the receipt of DBP's proposed revised access arrangement and invited submissions from interested parties. The proposed revised access arrangement, access arrangement information and related documents are available on our [website](#).

The issues paper will assist parties in preparing submissions. The issues paper is not intended to provide an exhaustive review of the proposed revised access arrangement for the DBNGP, or the matters that we will address when making a draft decision on whether to approve or not approve the proposed revised access arrangement. In our initiating notice we set a closing date of 4:00 pm (WST) Monday, 20 April 2015 for the public submission period. We have decided to extend the public submission period following the publication of the issues paper, to allow interested parties enough time to consider and refer to the issues paper when preparing submissions.

Interested parties are invited to make a submission on the proposed revision to the DBNGP access arrangement before **4:00 pm (WST) Tuesday, 2 June 2015**.
