## Determination of values for Ancillary Service Cost\_LR parameters

### INVITATION FOR PUBLIC SUBMISSIONS

On 24 November 2015, the Economic Regulation Authority (**ERA**) received a proposal from System Management on the values of the Ancillary Service Cost\_LR parameters for the three financial years from 1 July 2016 to 30 June 2019, under the *Wholesale Electricity Market Rules* (**Market Rules**).

These parameters determine the payments to market generators for the costs of providing Load Rejection Reserve Ancillary Service (“L” parameter), System Restart Ancillary Service (“R” parameter) and Dispatch Support Services that are not paid under specific contracts.<sup>1</sup>

An issues paper has been prepared to assist interested parties wishing to make submissions. The issues paper outlines the scope of the ERA’s role under the Market Rules, and sets out the matters that will be taken into account when assessing System Management’s proposal against the criteria in the Market Rules.
