NOTICE

INVITATION FOR PUBLIC SUBMISSIONS

ON THE PROPOSED HAULAGE CONTRACT BETWEEN ALINTAGAS NETWORKS PTY LTD AND ALINTAGAS SALES PTY LTD

This is to notify that the proposed Associate Contract between AlintaGas Networks Pty Ltd and AlintaGas Sales Pty Ltd for access to the Mid-West and South-West Gas Distribution Systems has been lodged with the Independent Gas Access Regulator, pursuant to Section 7.1 of the *National Third Party Access Code for Natural Gas Pipeline Systems* (the Code).

The proposed Associate Contract sets out the terms and conditions under which AlintaGas Sales Pty Ltd will be given access to the gas distribution systems operated by AlintaGas Networks Pty Ltd.

Section 7.1 of the Code requires that:

“A Service Provider must not enter into an Associate Contract without first obtaining the approval of the Relevant Regulator. The Relevant Regulator must not refuse to approve a proposed Associate Contract unless it considers that the contract would have the effect, or would be likely to have the effect, of substantially lessening, preventing or hindering competition in a market.”

Because the proposed Associate Contract provides AlintaGas Sales Pty Ltd with access to the gas distribution systems at tariffs other than the Access Arrangement reference tariffs, section 7.3 of the Code requires that an appropriate public consultation process be undertaken.

An issues paper has been prepared to assist interested parties with their submissions on the proposed Associate Contract. It outlines matters that I will take into account in assessing the proposed Associate Contract pursuant to section 7.1 of the Code.

Invitation to Comment

Accordingly, I invite comments from interested parties on the proposed Associate Contract. Specifically, comments are invited in relation to whether the proposed Haulage Contract would have the effect, or would be likely to have the effect, of substantially lessening, preventing or hindering competition in a market.

Submissions and comments on the proposed Associate Contract must be received by 5:00pm Tuesday 3 April 2001 Western Standard Time. Due to the time constraints imposed by the Code it will be important that parties making submissions are able to meet this time requirement.
