## NOTICE

### Revisions to the Goldfields Gas Pipeline Access Arrangement

#### EXTENSION OF TIME FOR THE FINAL DECISION CORRIGENDA

On 16 September 2009, the Authority issued a notice advising of the extension of the six month period to make a final decision regarding Goldfields Gas Pipeline's (GGP) proposed revised access arrangement.

This notice made reference to an extension under section 2.22 of the *National Third Party Access Code for Natural Gas Pipeline Systems* (Code) rather than an extension under section 2.44 of the Code. The erroneous reference to section 2.22 of the Code is of no material effect to the substance of the notice. The Authority has amended the error with this notice.

On 23 March 2009, the Authority received the proposed revised access arrangement and access arrangement information for the GGP from Goldfields Gas Transmission Pty Ltd (GGT), on behalf of Southern Cross Pipelines Australia Pty Ltd, Southern Cross Pipelines (NPL) Australia Pty Ltd and Alinta DEWAP Pty Ltd. On 22 April 2009, the Authority published an Issues Paper on GGT's proposed revised access arrangement to assist interested parties in making submissions. Submissions in response to GGT's proposed revised access arrangement are available on the Authority's [web site](#).

Section 2.43 of the Code provides that the Authority must issue within six months of receiving a proposed revised access arrangement, a final decision regarding that proposed revised access arrangement. The Authority is permitted under section 2.44 of the Code to extend the time frame to issue a final decision by up to two months on one or more occasions provided it publishes a notice of the decision to increase the period.

This Notice is to extend, under section 2.44 of the Code, the Authority's time frame to issue the final decision by two months to 23 November 2009.
