# **Invitation for Public Submissions**

## ALINTA SALES PTY LTD GAS STANDARD FORM CONTRACT

The Economic Regulation Authority is seeking public comment on amendments to the Alinta Sales Pty Ltd Standard Form Contract for the supply of gas to small use customers.

Many of the amendments reflect current obligations on Alinta under the *Compendium of Gas Customer Licence Obligations*. For example, the Standard Form Contract now provides that:

- a customer's bill includes reference to the customer's average daily consumption, average daily cost of consumption and the Energy Ombudsman's contact details;
- Alinta will suspend all disconnection and debt recovery procedures for 15 business days to allow customers who are experiencing payment difficulties to meet with a financial counsellor; and
- customers who do not pay their bill by the due date may be placed on a shortened billing cycle.

Under the *Energy Coordination Act 1994*, the Authority must not approve amendments to a standard form contract if it considers the amendments do not meet the relevant regulations, any other written law, or any term, condition or provision of the gas trading licence.

A copy of the proposed amended Standard Form Contract is on the Authority's website.

Interested parties are invited to make submissions in print and electronic form by 4:00 pm (WST) on Wednesday, 3 November 2010.
