Wesfarmers Kleenheat Gas Pty Ltd

GAS STANDARD FORM CONTRACT

The Economic Regulation Authority is seeking public comment on proposed amendments to Wesfarmers Kleenheat Gas Pty Ltd's Standard Form Contract for the supply of gas to small use customers.

The Authority requested that Wesfarmers Kleenheat Gas Pty Ltd review its Standard Form Contract to ensure that it complies with the requirements of the new Australian Consumer Law as well as the current version of the *Gas Marketing Code of Conduct* and the *Compendium of Gas Customer Licence Obligations (Gas Customer Code)*. Wesfarmers Kleenheat Gas Pty Ltd has completed its review and has requested that the Authority approve amendments to its Standard Form Contract.

Under the *Energy Coordination Act 1994*, the Authority must not approve amendments to a Standard Form Contract if it considers the amendments do not meet the relevant regulations, any other written law, or any term, condition or provision of the gas retail licence.
